PREFACE

Presented here is the annual report for the Procurement Policy Board proposed contract review. Pursuant to Section 5-30 of the Illinois Procurement Code, no contract procured above the small purchases limit may be executed until 30 days after notice of its award or letting appears in the Procurement Bulletin, without the Procurement Policy Board having the opportunity to review the proposed contract. The contracting agency may request, and the Board may agree to waive the 30-day period as necessary.

PPB review occurs on proposed contracts that appear contrary to existing policy, contracts that are proposed under newly established policy and contracts that are particularly unique and don't find a ready course through existing procurement policy.

This report provides details on the State's contracting activity in the areas of sole source, emergency, professional and artistic, and construction contracts. Contract extensions and their associated details are also presented in addition to renewed contracts. The Procurement Policy Board collected the data recorded in this report from notices published in the Illinois Procurement Bulletins. Four separate Bulletins are employed by the State, one each at the Department of Central Management Services, Illinois Public Higher Education, Department of Transportation and Capital Development Board. From the data collected, the Procurement Policy Board initiated several reviews of specific proposed contracts. Each of those reviews is included in this report.

The reporting process for proposed contracts also allows capture of data that shows:

- 1. Total Spend by Agencies and Universities under the jurisdiction of review
- 2. Aggregate number of published transactions broken down by different categories
- 3. Aggregate dollar value of published transactions broken down by different categories, and
- 4. Specific values associated with sole source, emergency, professional and artistic and construction contracts

It is the Board's desire that the report will be used to better shape procurement policy and recognize trends so that future individual procurements will be made with the best possible understanding of historic procurement facts and dimensions.

OVERVIEW:

On May 30, 2007, the Procurement Policy Board placed the Illinois Department of Central Management Services lease for the Department of Revenue at 1854 Besly Court in Chicago under review. The Procurement Policy Board is concerned with the relationship between the leasing of space that is contingent upon other business transactions occurring. Specifically, in the leasing of this space, it was referenced that a contract for billboard advertising was directly related and contingent to occupancy. The Board is concerned about procurement policy that authorizes contract contingencies and how contingent contracts are solicited and awarded. The Board is exploring the State's policy on vendor selection in this environment.

STAFF CONSIDERATION:

Staff requested copies of all documents relating to this lease, including the Department of Revenue's space request, the current and proposed leases, evaluation documents and any form or decision memo related to the consideration and approval of the proposed lease. This warehouse space is RFI Exempt (Procurement Code, Section 40-15(b) – Property of less than 10,000 square feet/Rent of less than \$100,000 per year). In addition, staff contacted the Department of Revenue with a request for more information regarding the lease of the billboard.

The procurement office at the Department of Revenue (DOR) was not directly involved with the lease of the billboard – as with all media buys, it was handled by the Lottery's advertising agency, R.J. Dale Advertising. The DOR explained that utilizing the expertise of an advertising agency for media buys ensures that they place relevant ads in a timely manner and in a way that maximizes their impact. The \$36,500 per month cost of the billboard lease is paid from the advertising budget. In addition, the only thing unique about the acquisition of space on the Tri-Vision board vs. other billboards throughout the state is the requirement of a Chicago zoning law that anyone having their ads on Tri-vision must also have a presence in the building because the sign is located within 500 feet of an expressway (Chicago Municipal Code, zoning ordinance, 17-12-1000). The warehouse space lease that is a condition of use for the Tri-Vision board was handled by the Department of Central Management Services. DOR also confirmed that the warehouse is in use for the storage of Lottery-Owned Instant Ticket Dispensing Machines, as well as miscellaneous banners and other promotional materials.

The timeline for this proposed lease included an appropriate space request from the using agency that stated the contingent relationship and that the warehouse would hold instant lottery distribution equipment. This arrangement as required by Chicago ordinance was not clearly understood by CMS Leasing at the onset of this review. The review resulted in documentation being forwarded to CMS leasing for their records. No further consideration occurred.

PROPOSED POLICY RECOMMENDATION:

No action was taken on this review.

OVERVIEW:

On July 3, 2007, the Procurement Policy Board placed the University of Illinois at Urbana-Champaign order for the Portable Audience Chairs under review. The Procurement Policy Board is concerned with the development of specifications and their issuance when a single manufacturer's data serves as the basis for the specification. When this occurs, it is standard for the solicitation to allow "approved equals" to be bid. The Board is examining how this type of specification might limit competition.

STAFF CONSIDERATION:

Staff requested copies of all documents relating to this purchase, including the requesting department's requisition, the current and proposed contracts, evaluation documents and any form or decision memo related to the consideration and approval of the proposed order. Prior to this solicitation, the University sought to designate the purchase as a "sole source" as requested by the requisitioning department. The Department supplied drawings and specifications for this specific product. The PPB did not agree and asked that a competitive selection process occur. The University agreed and used the sole source vendor's drawings and specifications as the standard for competitive selection. The competitive result was that the vendor supplying the specifications was the only vendor to respond.

The Board has informally requested all agencies to conduct transactions that are descriptive rather than restrictive. The Board has also encouraged multiple specification standards if products qualify as "approved equals". Most competitive selections that set a single standard and allow "approved equals" only yield the standard that was specified. They most often yield only one vendor. This happens with automobiles, tractors, and commercial equipment of all varieties. Dozens of transactions have been conducted in this way with identical results. The informal suggestions have generally not been implemented. Staff considered that a unique standard was necessary before asking for a competitive selection. Staff could not identify such a standard.

PROPOSED POLICY RECOMMENDATION:

It is recommended that in all cases where "approved equal" standards are utilized, that the procuring agency identify which specifications are mandatory, which specifications are meets or exceeds, and which specifications are termed desirable or negligible.

OVERVIEW:

On November 20, 2007, the Procurement Policy Board placed the Illinois State University order for a New Recycling Truck under review. The Procurement Policy Board is concerned with the award to other than lower bidder for a reason that was not a part of the original bid specifications. The Board is examining how this type of award may impact future awards to other than low bidder in general.

STAFF CONSIDERATION:

Staff requested more information on this procurement and was provided with the SPO determination that it was in the best interest of the University to award to other than low bidder, in addition to the two vendors' bid clarification documents. The solicitation contained only one reference to delivery of the vehicle, "In the event a new vehicle cannot be ordered the dealer is to provide a copy of the sticker, indicating the standard and optional equipment on an in stock vehicle." which implied that immediate delivery was not mandatory. After the bid opening, the University's current recycling truck became unusable and the University was forced to rent a replacement vehicle for approximately \$350 per week.

The competitive result was that the low bidder supplying the specifications was able to supply a vehicle in four weeks, but the second low bidder had immediate availability. Since the issue came up after the bid opening, the University was unable to alert the vendors that immediate delivery was now considered necessary. The University awarded to the second low bidder since they were able to deliver the vehicle immediately. The award document also stated that the total cost of the procurement led to selection of other than the low bidder. No reference to that type of evaluation was included in the solicitation.

Staff was also concerned that the award process had been disclosed in that the buyer contacted the low bidder to convey the reason behind the award to the second low bidder before posting. The University later stated that they had communicated on the date the award was posted in order to maintain a good business relationship with the low bidder.

PROPOSED POLICY RECOMMENDATION:

It is recommended that, for all solicitations, delivery expectations should be in the documents and that any business factors that relate to the "cost of the procurement" or "total cost of ownership" be disclosed so that the vendor can supply and price to the best of their ability.

AGENCY COMMENTS:

Agency concurred with the Board's recommendation and implemented.
